Note:

- 1 Refundable Security deposit (interest free) to be paid at the time of Admission.
- 2 Tuition Fee shall be paid term wise within first week of the term as mentioned above.
- 3 Tuition fee for any special skill will be charged extra as per actuals.
- 4 **Transport and Cafeteria shall be optional. Separate fee for these heads shall be informed prior to providing the services.**
- 5 Uniforms, Books, Stationery and other such utilities shall have to be purchased separately from vendor
- 6 All fee payments may be made via Demand Draft/ Cheque favouring "The Shri Ram Universal School" or through the ShriConnect portal directly.
- 7 A late fee @ INR 250 per day (including Saturday & Sunday) shall become payable, on failure to clear dues by the stipulated date.
- 8 A cheque dishonour fine of INR 500 shall be applicable.
- 9 All bank charges pertaining to inward remittance of school fee, if any, shall be debited to students' account.
- 10 Credit card & Debit Card Transactions shall incur a processing fee of 1% on all payments including payment done through Shri Connect Parent portal.
- 11 Special activities, learning journeys, external examinations, subscriptions etc. shall be charged at actuals and intimated to the parents, with shortfalls/excesses recovered/ retained from students' account time to time.
- 12 In general, a yearly increase of around 10% in Tuition fee may be expected apart from slab increase where ever applicable.
- 13 All applicable taxes shall be in addition to the fees mentioned above. Parents shall be intimated of any other taxes, apart from GST, as may become applicable from time to time.
- 14 No internal examination results, reports, transfer certificate or recommendations to future schools will be issued to the defaulting student whose fee remains unpaid in full or in part until the outstanding fee is received. All the dues shall be forfeited from the security deposit.
- 15 The Shri Ram Universal School has put in place policies and regulations necessary for effective functioning of the school. The School reserves the right to amend its policies and fee structure whenever considered necessary and appropriate.
- 16 Your ward shall abide by The Shri Ram Universal School policies and regulations, including amendments and modifications therein, as may be applicable from time to time.
